There is some concern about the registration fee and food cost since there are no in-house restaurants. The goal is to keep the rate at \$275, which includes the opening and 3 meals. Yvette and the committee plan to walk through the plan at the membership meeting on Saturday at 2pm.
- **B.** During discussion, it was stressed that this document is a guiding, living road map that can be altered along the way.

**C.** Yvette motioned to approve the strategic plan. Keldy seconded. The Motion passed unanimously.
